12. Heath- social and rec. Checks: approval to send checks from annual meeting.


13. Cleaning contract. Supervisor Holcomb made a motion to accept the cleaning contract. Supervisor Hadhazy seconded. All were in favor.

**PUBLIC COMMENT** – None.


**OTHER DISCUSSION** – None.
